Gentry LEADS

We have ten teachers who will continue in the Bloomboard Microcredential program. We are working to enroll new participants in the program at this time.

There are four teachers who will continue in the HRT program. Melinda Ramsey has been designated as a Level One HRT. Rebecca Summers is on target to be designated as HRT Level One by the end of April. We have many additional teachers who are in the process of enrolling in the HRT program for next year.

District Literacy Specialist Update

24 sessions of RISE training have been completed in our district as of this month. The District Comprehensive Literacy Plan has been updated for next year. K-12 reading/ELA curriculum resources can be found here.

Dyslexia Specialist Update

We are currently on track at the high school to exit all students in our dyslexia intervention class, Academic Reading, this year. We will not have the need to request an Academic Reading Year 2 for these students based on meeting exit criteria. The purchase and implementation of the iSpire dyslexia approved program has been a success tool this year for student growth and for meeting state required guidelines.

Moving forward, any students that do not complete the Phonics Structures dyslexia program provided in our Reading Lab on the middle school campus by the end of 8th grade will automatically be placed in Academic Reading at the high school for their 9th grade year. Thus, Reading Lab at the middle school will only serve 6th through 8th graders and Academic Reading will serve 9th graders and above as needed.

To date this school year, we have had just over 40 students given a level 2 dyslexia battery. These students were chiefly referred by teachers that recognized their struggles and this is a great testament to the growing awareness among our educators.
