Who is a Pioneer Virtual Learning Academy Student?

- A student who is a self-starter and who has demonstrated this capacity in academic settings
- A student who has a consistent, supportive parent or guardian available to regularly monitor progress
- A student who recognizes the challenge of working independently and at a self-selected pace
- A student who practices habitual communication. Students and parents are expected to proactively contact teachers when additional academic support is needed

Student Contract

- I understand that when attending live class instruction I will be appropriately dressed and exhibit behavior that is consistent with the school handbook.
- I understand it is my responsibility to proactively communicate with my teachers when I need help (via email, Google Classroom, Zoom), reply to teacher emails, and attend live or online tutoring/intervention sessions when assigned. It is also my responsibility to regularly check my email and grades on HAC.
- I understand courses will be rigorous and to be successful, I need to dedicate time each day throughout the week to view my classrooms and complete assignments by the due date.
- I understand that if my progress is unsatisfactory in my core classes (lower than 70%), I am required to attend live class instruction on Monday, Wednesday, and Thursday until grade and performance improve and teacher approval has been given.

- If I do not attend required classes when my progress is unsatisfactory, complete the attendance form, or do not maintain a 70% or higher in 3 or more core classes at progress report or quarter, I will return to on-site learning.
- I understand that once I have enrolled in Pioneer Virtual Learning Academy, I will be expected to successfully complete a full year in the academy unless a significant life event such as divorce, death, or employment change warrants a change in placement at semester.
- I understand I may need to be present on campus to take all state-mandated and district-mandated assessments and will be required to attend a virtual school orientation prior to the start of school.

Parent Contract

- I understand that attendance for live class instruction is required only if my student's grade is below 70% in a class and they must attend live class instruction on Monday, Wednesday, and Thursday until teacher approval has been met.
- As a parent of an online student, I understand that my responsibilities include reviewing assignments, maintaining correspondence with teachers, and if needed, bringing my student to campus for interventions, assessments, or on-site course offerings.
- I understand I am responsible for regularly checking my student's grades on the Home Access Center (HAC) and ensuring open lines of communication with my student's teachers.
- I understand my student will need to be transported to campus for all state-mandated and district-mandated assessments as well as any required screenings.
- I will regularly check email as well as the school webpage for school updates, mandated state testing dates, and school updates.
- I understand that if my student's progress is unsatisfactory in their core classes (lower than 70%) they are required to attend live class instruction on Monday, Wednesday, and Thursday until grade and performance have improved and teacher approval has been submitted.
- If my student is unable to meet expectations (70% or higher in 3 core classes) at progress report or quarter and/or be successful in online classrooms (attend live classes on Monday, Wednesday, or Thursday and complete the attendance form if below 70% in a class) they will be removed from the virtual academy and be returned to on-site instruction.
- I understand that my student must dedicate time each day throughout the week to check their Google classrooms for assignments and complete by the posted due date.
- I understand the importance of my role and will work to ensure my student's success in online settings by
 ensuring they are ready to learn and are exhibiting appropriate dress and behavior when attending live
 classroom instruction or attending an on-site course.
- I understand that my student and at least one parent or guardian will be required to attend a virtual school orientation before the start of school.
