**Dispute Resolution:** This agreement shall be interpreted and construed in accordance with Kansas law. Any dispute arising out of or relating to this agreement shall be resolved by binding arbitration in Johnson County, Kansas. Parties agree to appoint a single arbitrator and that mediation is a precondition to either party filing a demand for arbitration. Any judgment rendered by the arbitrator may be confirmed, entered, and enforced in any court having jurisdiction and Contractor and Customer agree to

and shall be bound thereby. The prevailing party in any such action shall be entitled to an award of its costs and reasonable attorney fees.

Payment Terms: Contractor will invoice Client for contracted recurring services with payment expected at conclusion of service for the month that service is billed. Contractor may also bill on a twice per month schedule, with payment expected on the 1st and 15th of the month invoiced. (EXAMPLE: Contractor will pre-bill for December services at the first of December with payment expected by the end of December.) For one-time projects and service(s) provided under this agreement, Customer agrees to pay the total charge listed above plus all applicable taxes, within thirty (30) days of invoice date. Should Customer fail to pay the entire amount by the deadline, SG360 shall have the right to charge a late fee of 1% on any unpaid amounts.
