## RESOLUTION

### A.C.A. § 6-24-101 et seq.

Whereas the **Gentry School District** Board of Directors met in a (regular/special), open, and properly called board meeting on December 19, 2022, Pioneer Activities Complex/Hospitality Room, in Gentry, Arkansas.

Whereas        members were present, a quorum was declared by the chair.

Whereas the Board of Directors received a recommendation to adopt a resolution to enter into a contract with **Rebecca Tingley d.b.a Tingley Tees**

Full disclosure of all relationships and interest as required by A.C.A. § 6-24-101 et seq. that are relevant to proposed contract: **Rebecca Tingley is a certified employee of the district. In non-contracted, non-school hours she operates a business, Tingley Tees which provides vinyl products such as T-shirts, cups, bags, and stickers.**
